ESCape reserve the right to **move** the locations of Holiday School sessions, **cancel** or **amalgamate** them should the numbers of children attending the proposed Holiday School not reach the required minimum numbers for that session or too many children apply or the accommodation is not available for whatever reason.

It is our intention that our Holiday School will be open 4 days a week from Tuesday 3^{rd} April to the 12^{th} April , however there may be occasions when for reasons out of our control, we may decide to close the Holiday School for safety or other reasons. When a decision is made to close the Holiday School, we will notify all parents as soon as possible by telephone and email. Parents will be expected to collect their child by the time given for closure.

Our staff are usually school based employees and all staff have completed the DBS disclosure.

ESCape scale of charges are as follows:

Full Day 8am – 6pm (including snacks and light refreshments) £25 Half Day 8am -1pm or 1pm – 6pm £15 Additional fees may be payable for outings. Please check the programme for this information.

Discounts offered - advance booking and payment for 4 full days and get the fifth free!

Discretionary places – We are able to offer a limited amount of discretionary sessions. If you would like to apply for one of these sessions, please contact your school office in confidence or email holidayschool@consortiumacademy.org (Children must attend either host school to qualify.)

All booked sessions are payable for in advance, and sessions cannot be swapped without prior agreement from the management.

Full fees will be payable if your child is absent from the Holiday School for any reason unless 48 hours prior notice is given to the management.

ESCape Holiday School cannot be held responsible for any loss or damage to personal property
